

Subj: Malaga Acquisition

Malaga County Water District met again with Mr. Chris Krier and another representative from CHSRA on 12 January 2017. It was anticipated that the work done over the past 2 ½ years would proceed in a positive direction. What instead occurred was receipt of a new proposal bringing us right back to square one of August 2014.

Malaga County Water District cannot accept any terms for this acquisition until our concerns are met regarding the potential impact of the project on the disposal ponds at the wastewater treatment facility. Malaga County Water District has spent thousands of dollars trying to accommodate CHSRA. As requested, we submitted a detailed staffing plan based upon a complete review of the project in a memo dated 14 March 2016. Mr. Krier indicated at the last meeting that CHSRA does not agree to a substantial portion of the staffing plan. Malaga County Water District has been pressing for design plans that are adequate to make calculations to determine the impacts of the project on the ponds. Until we receive such plans, Malaga County Water District has no other way than the staffing plan to determine potential impacts of this project.

Malaga County Water District has received no assurances other than verbally that work on the project will not impede the District's ability to conduct normal business as required in the NPDES permit that regulates operations of the wastewater treatment facility. We find it impossible to believe that the contractor will limit all construction activity to the narrow strip of land in the acquisition proposal. Malaga County Water District must have written assurances by an agreement that includes compensation for impedances and inconveniences that are inevitable for a project of this scope.

The package of documents received at the 12 January meeting do not address any of these concerns. I will not bother to incur further expenses submitting these documents for additional engineer review until CHSRA demonstrates the ability to work with Malaga County Water District in good faith.
