b. **WWTF Pond Gates.** Grizzly Construction has provided a proposal to replace the twelve incorrect gates and replace four other gates that were not previously changed. The proposal is to change the erroneous gates at a cost of \$22,461.00 which includes a credit of \$11,454.00 for the incorrect gates. The proposal also includes \$16,060.00 to replace four gates that were not previously replaced. The total cost of the proposal is \$38,521.00.

RE: Request for VETO of SB 998 (Dodd)

Dear Governor Brown:

On behalf of the Malaga County Water District, we are writing to urge your VETO of SB 998 by Sen. Bill Dodd (D-Napa), which would unnecessarily create a new statewide program for water service shut-offs.

California's public water agencies deliver safe, reliable, high-quality and affordable water to customers in a dependable and responsible manner. This new one-size-fits-all statewide program would, among other things, trigger Prop. 218 concerns for public water agencies, and expand authority to both the State Water Resources Control Board and the Attorney General to enforce provisions of the bill.

Malaga County Water District is overseen by a locally elected Board of Directors that makes decisions based on what is in the best interest of the agency's constituents. Water agencies are in the business of delivering water — they don't disconnect delinquent customers without prior substantial engagement. Our District Ordinance contains adequate water shut-off procedures with humanitarian considerations that fits the needs of our disadvantaged community.

This bill is unnecessary and appears to be a solution in search of a problem that does not currently exist in California. For these reasons, the Malaga County Water District respectfully urges you to veto SB 998.
