

III. PROJECT DESCRIPTION:

The project will add polyurethane foam over the existing metal roof to provide insulation and seal leaks. The project will also replace existing evaporative coolers with an air conditioning system.


IX. OUTCOME MEASUREMENTS:

Total number of persons to be assisted with improved access to facility or infrastructure benefit: 4,850

X. BACKGROUND INFORMATION / RECENT PROJECT SUMMARY:

- A. The proposed improvements will increase the comfort level of the community center, especially on hot days, and eliminate leaks in the current roof.
- B. The Wastewater Treatment Plant Improvements Project No. 12451, funded in the fall of 2012, is complete. The Notice of Completion was filed on March 25, 2015. The project required two scope modifications, and two time extensions, extending the project by eleven months.
- C. The most recent completed CDBG project in Malaga, Malaga No. 3 and No. 5 Water Test Wells, was funded in the fall of 2013. The project was completed in September, 2016. The project required one scope modification and two time extensions, extending the project by 20 months.
- D. Six letters and a petition with approximately 1,445 signatures were submitted in support of the application.
