**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE MALAGA COUNTY WATER DISTRICT AS FOLLOWS:**

1. That the foregoing Recitals are true and correct and are incorporated herein by this reference as though fully set forth at this point.
2. That the Board of Directors of the Malaga County Water District recognizes the efforts of Community Volunteers in providing events, services and activities for the community and thanks all of the Volunteers for their service.
3. It shall be the policy of the District that the efforts and service of Volunteers be recognized.
4. Effective the date of this Resolution, all recognition of Volunteers in the District shall be in the form of non-monetary recognition and that the General Manager is hereby directed to developed policies and procedures whereby Volunteers can be recognized for their great service to the District in non-monetary manners such as

Awards, Proclamations, Appreciation lunches or other non-monetary forms of recognition consistent with this resolution. Any event requests prior to the date of this resolution will not be effected.
