RESOLUTION NO. 06-12-2018

THE BOARD OF DIRECTORS OF THE MALAGA COUNTY WATER DISTRICT ORDERING EVEN-YEAR BOARD OF DIRECTORS' ELECTION, CONSOLIDATION OF ELECTIONS, AND SPECIFICATIONS OF THE ELECTION ORDER

WHEREAS, California Elections Code requires a general district election be held in each district to choose a successor for each elective officer whose term will expire on the first Friday in December following the election to be held on the first Tuesday after the first Monday in November in each even-numbered year; and

WHEREAS, other elections may be held in whole or in part of the territory of the district and it is to the advantage of the district to consolidate pursuant to Election Code Section 10400.

WHEREAS, Elections Code Section 10520 requires each district involved in a general election to reimburse the county for the actual costs incurred by the county elections official in conducting the election for that district; and

WHEREAS, Elections Code Section 13307 requires that before the nominating period opens the district board must determine whether a charge shall be levied against each candidate submitting a candidate's statement to be sent to the voters; determine the number of words, may estimate the cost; and state the estimate must be paid in advance; and

WHEREAS, Elections Code Section 12112 requires the election official of the principal county to publish a notice of the election once in a newspaper of general circulation in the District;

NOW, THEREFORE, BE IT RESOLVED that an election be held within the territory included in this District on the **6th day of November, 2018**, for the purpose of electing members to the Board of Directors of said District in accordance with the following specifications:

RESOLUTION NO. 6-12-2018A

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MALAGA COUNTY WATER DISTRICT DECLARING IDENTIFIED REAL PROPERTY TO BE SURPLUS PROPERTY OF THE DISTRICT AND AUTHORIZING ISSUANCE OF NOTICE OF AVAILABILITY FOR SALE OF SUCH SURPLUS PROPERTY IN ACCORDANCE WITH THE PROVISIONS OF GOVERNMENT CODE §54222

WHEREAS, the Malaga County Water District ("District") is the owner of vacant land located at 4335 S. Maple Avenue at the corner of S. Maple Avenue and E. Malaga Avenue in the City of Fresno also identified by Fresno County Assessor Parcel Number 33003111T consisting of approximately 4.35 acres of land zoned by the City of Fresno as IH (Heavy Industrial) hereinafter referred to as the "Real Property"; and

WHEREAS, the Real Property was purchased for the purpose of providing the District with overflow pond capacity for its Waste Water Treatment Facility ("WWTF") however, due to the implementation of a pond maintenance program the District currently has sufficient capacity in its existing ponds and, in the event the District requires additional capacity at its WWTF, recycling or reclamation or water from the WWTF would be preferable to placing the water in percolation ponds rendering the Real Property no longer required by or suitable for the District for any public purpose of service performed by the District and therefore surplus; and

WHERAS, the District desires to declare the Real Property surplus real property and to dispose of the Real Property by sale as provided by law.

NOW, THEREFORE, be it resolved by the Board of Directors of the Malaga County Water District as follows:

- 1. The foregoing recitals are true and correct and incorporated by this reference as though fully set forth at this point.
- 2. The District declares the aforementioned Real Property to be surplus real property of the District and authorizes the General Manager to publish the fact of this declaration and give notice of the availability of the property for sale in the manner permitted and/or required by Government Code §54222.
- 3. The District has had the Real Property appraised with a value of \$375,000 as of May 2, 2018.

- 4. The General Manager is authorized to issue a written solicitation of offers to purchase the Real Property to the City of Fresno and the Fowler Unified School District and any other public entity within who's jurisdiction the Real Property is located that is required to receive notice pursuant to Government Code §54222 specifying the minimum price at the appraised value, \$375,000.
- 5. If no entity or association gives the District notice that it desires to purchase the surplus property within 60 days after notice is given then the General Manager shall inform the Board that no entity or association is interested in purchasing the property so that the Board may direct the General Manager to dispose of the surplus Real Property in accordance with State law and the District's policies and procedures.

RESOLUTION NO. 6-12-2018-B

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MALAGA COUNTY WATER DISTRICT RESCINDING AND RE-ADOPTING THE CONFLICT OF INTEREST CODE FOR THE MALAGA COUNTY WATER DISTRICT

WHEREAS, the Political Reform Act, '81000, et seq., of the California Government Code requires every state or local government agency to adopt and promulgate a conflict of interest code; and

WHEREAS, Government Code '82011 designates the Board of Supervisors of the County of Fresno as the Code Reviewing Body for the Malaga County Water District ("District"); and

WHEREAS, the Fair Political Practices Commission has adopted a regulation, 2 Cal. Code of Regs. '18730, which contains the terms of a standard conflict of interest code which may be amended, from time to time, by the Fair Political Practices Commission after public notice and hearings which may be incorporated by reference by a local agency; and

WHEREAS, the Board of Directors of the Malaga County Water District desires to as part of the required bi-annual review; make certain non-substantive amendments to the Conflict of Interest Code previously adopted by the District and approved by the County Board of Supervisors; and

WHEREAS, the Board of Directors of the Malaga County Water District does, from time to time, consider and direct the investment of public funds; and

WHEREAS, on June 12, 2018, the Malaga County Water District held a duly noticed public hearing to review and consider amending the District's conflict of interest code; and

NOW THEREFORE, BE IT RESOLVED by the Board of Directors of the Malaga County Water District as follows:

- 1. That this Resolution shall rescind all prior resolutions adopting a conflict of interest code and adopt this new conflict of interest code for the Malaga County Water District.
- 2. The Board of Directors of the Malaga County Water District does hereby adopt the proposed Amended Conflict of Interest Code, a copy of which is attached hereto and incorporated herein by this reference and shall be on file with the Board Secretary and available to the public for inspection and copying during normal business hours.

3. Section 1020 of the District's Policy and Procedure Manual as hereby amended to read as follows:

"Section 1020 - Conflict of Interest Code

1020.10: The District shall adopt and/or renew its Conflict of Interest Code every even numbered year as necessary. A copy of the District's Conflict of Interest Code shall be kept on file with the Secretary to the Board and available for public viewing at the District office."

- 4. That the Secretary of Malaga County Water District Board of Directors shall submit a certified copy of this Resolution containing the conflict of interest code to the Fresno County Board of Supervisors, as the Code Reviewing Body.

CONFLICT OF INTEREST CODE OF THE MALAGA COUNTY WATER DISTRICT (Adopted July 10, 2018)

The Political Reform Act, '81000, et seq., of the California Government Code requires state and local government agencies to adopt and promulgate conflict-of-interest codes. The Fair Political Practices Commission has adopted a regulation (2 Cal. Code of Regs. '18730) which contains the terms of a standard conflict-of-interest code and may be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 Cal. Code of Regs. '18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Appendixes designating positions and establishing disclosure categories, shall constitute the conflict of interest code of the Malaga County Water District.

The Form 700s for designated positions, other than members of the District's Governing Board and the District's General Manager, shall be filed with the District. The District's Directors and General Manager are to file their original Form 700s directly with the Clerk of the Board for the Fresno County Board of Supervisors using the electronic filing system. If the Form 700s are not filed electronically, the paper Form 700 and waiver shall be filed with the District and, upon receipt of these Form 700s with waivers, the District shall make and retain a copy and forward the original to the Clerk of the Supervisors.

The District shall retain a copy of all electronically filed Form 700s, a copy of all paper Form 700s with waivers and the original Form 700s of designated positions and shall make the Form 700s available for public review, inspection, and reproduction. (Gov. Code §81008.)

The provisions of all Conflict-of-Interest codes and amendments thereto previously adopted by the agency are hereby superseded.
